#### Why do a Park Master Plan?

- To follow a process to determine the suitability of the land for future restoration of the park and recreation facilities (soils, vegetation, shoreline currents, views, accessibility connectivity, views, etc.)
- To determine what types of recreation & park program areas could occur within the park.
- To provide a forum that allows public/stakeholders to give input throughout the planning process.
- To aid in the preparation of preliminary cost estimates & budgeting for capital improvements.
- To enable eligibility to participate in certain grant programs.

#### But most importantly.....

 To provide a common vision for phased park facility development & park land management that balances public use with resource protection.

- Improving non-motorized connectivity to other parks and trails
- Emerald Ash Borer/Future Treescape
- □ Storm Water Runoff/Hydric Soils
- Potential barriers to use of the park. (CTH M)
- User demographics. (Older & Young Families)
- Middleton CORP (Underserved/more playgrounds)
- Parking and internal circulation.
- Campground upgrades needed. (water, electrical, restrooms, improved sites, tent sites)



# Neighborhood, staff, stakeholder, public input themes.

- Second most popular Dane County campground
- Remove existing 2 smaller shelters
- Beach/breakwater/pier ideas
- Parking/circulation is dysfunctional
- More playground areas/nature based
- Consider mental health, lake provides urban relief
- Concerns of visibility of channel/proximity playground
- More trails so don't have to walk on roads/parking lot
- Very diverse population using parks
- Drainage issues/stormwater concerns
- Improve CTH M pedestrian crossings
- Add Canoe/Kayak storage racks
- Support Fireplace/Labyrinth
- Concern shoreline floating weeds
- Consider art in the park
- Minimum to no additional staff maintenance required

## Proposed shelter area improvements

- Replace shelter with timber frame shelter
- Leave existing willow for separation of spaces
- Add firepit/benches at point

## Proposed channel area improvements

Repair sea wall/boat rub rail board
Replace limestone walk with concrete
Remove or replace existing timber wall.

# Proposed Campground Improvements

- Add flush toilet building (2 unisex)
- Add 3 drinking water stations
- Improve visual screening
- Convert 4 RV sites to pull through sites
- Add 5 rustic sites (tent)
- Relocate host site



# Proposed Parking Lot/Circulation Improvements

- Existing : 89 car, 7 boat trailer
- Proposed:94 car, 8 boat trailer
- Decrease Pavement Area Existing Parking Lot
- Add Parking Closer to Lake/Beach/Shelter
- Move Trailer Parking Closer to Ramp
- Improve Camper/RV Dump Station Circulation
- Add Stormwater Management Improvements
