1. Call Meeting to Order

Meeting called to order at 3:40 PM on 10/13/2020

2. Approve Agenda

Motion to approve by Jodi Helgeson, second by Kelly Felton. Approved unanimously.

3. Approve Minutes from 2020 Annual Meeting

a. Motion to approved by Jodi Helgeson, seconded by Jeremiah Erickson. Approved unanimously.

5. Legislative Technology Services Bureau (LTSB) – represented by Ryan Squires of the LTSB

- a. Thanks extended to Pilot project participants
- b. Virtual Training Session in January for LIO correction of block geometry for all municipalities. (3rd/4th week of January)
- c. Submit Ward Boundaries for 2021 in March instead of January, in prep for redistricting.

6. Department of Administration (DOA) update by Peter Herreid

- a. Response to LION Survey results
 - i. Response letter sent out earlier today.
 - 1. DOA agreeable to most concerns.
 - 2. No schema changes anticipated for 2021 statewide parcel submission.
 - 3. V8 schema changes for 2021 submission should be to December 17th, 2021
 - 4. V9 schema changes for 2022 submission should be to December 1st, 2022
 - 5. Acknowledged that October 30th might be difficult to meet.
 - 6. Counties still allowed a flexible cut-off date for statewide parcel submission
 - 7. More LION Input is soundly supported.
 - 8. Agree that Link to DOR is a goal, but no current standardized requirement for tax data submissions to state. Would be interested if all 72 counties can commit to getting XMLs to state
 - a. Fred lausly asked if DOR is looking into working on making the standardized database that could relieve counites of need to process data that is ultimately sent to DOR.
 - i. Peter responded that they are well short of the 72 needed counties submitting XML.

- b. Mike Friis reminded that we'd need to require counties to submit in XML format.
- c. Discussion on why DOR does not have a formatted database to link to geometries. (Fred, Jeremiah, Peter, Me)
- 9. Thanks from Fred lausly and Zachery Newton to DOA for their response to LION survey letter
- b. Program Status Update
 - i. Grants at \$50K
 - ii. Most docs since 2013, with no apparent signs of slowing.
- c. Opening on the WLIC (LIO Representative)
 - i. County representative term ends 12/31/2020.
 - ii. Accepting applications.
 - iii. Kelly Felton is current representative and can continue if need be.
- d. Reminder to pay mind to observation reports as strategic grant preparation goes forward.
- e. Finished final report on Statewide parcel map
- f. 2022-2024 Land Information Plan will be undergoing a comprehensive update in 2021 (early) DOA will be seeking LIO input on changes.
- g. Reminder of Route to Recovery Grants

 - ii. Unbudgeted expenses in Land Information Offices and County governments.
 - iii. \$210 Million budgeted. ½ was scheduled for counties.
 - h. Eric Damkot expressed concern on 2022 plan changes to be accounted for as early as possible in 2021. Peter Herreid acknowledged that concern.

- a. Kelly Felton is interested in continuing as the county rep on WLIC. Discussion ensued.
- b. Jodi Helgeson moved, Jeremiah Erickson seconded to reappoint Kelly Felton as the County representative on the WLIC for the forthcoming term beginning 1/1/2021.
- c. Support from LION community on the call was unanimous.
- d. Mention that LION may still need to supply support letter and Felton will need to file a formal application.

8. Any other business

- a. Fred Counties will be getting a contact from GeoComm on their gap analysis.
- b. Kelly reminded everyone of WLIC council meeting on 10/14/2020 at 9:00 AM
